Could you offer a Welcoming Space?

Cllr Matt Golby, Cabinet Member for Adult Social Care and Public Health

Our Council is looking to partner with more community and voluntary organisations to re-launch a scheme which aims to support vulnerable people across West Northamptonshire.

Town and Parish Councils were instrumental in the success of last winter's warm spaces initiative, and I would like to thank you all for your support.

I am really pleased to say we are launching this essential initiative for a second year, and I would like to ask for your support in offering community buildings to act as spaces for

Relaunched as Welcoming Spaces, the scheme aims to tackle loneliness and social isolation by providing residents with a place to go where they can meet new people, socialise and access support services whilst being in the warm, and all within reach of where they live.

Each of the spaces can choose what they wish to offer, from cups of tea to knit and natters or board game activities for



example. The last programme saw 96 community and voluntary partners sign up to be a warm space, which saw over 52,932 attendees visit between January to March 2023 putting a spotlight on how important this support is for residents.

You will all know that the winter months in particular can be a challenging time for many – whether it be due to financial worries, struggling with household bills or feeling a bit lonely. By working together offer welcoming spaces, we can enable a real community focused approach that can help to address these challenges and provide support that can be used and accessed locally by residents. We are really encouraging community and voluntary organisations to register – whether that's new organisations or those who were involved last year registering again. We have had a great response so far with 40 organisations registered to date.

As part of the registration for the welcoming spaces, organisations will be invited to apply for the Welcoming Spaces Grant that has been developed to further enhance the welcoming spaces by providing funding to voluntary and community sectors organisations.

Latest update on school closure announcement

Work is under way to make alternative arrangements for all children affected by Southfield Primary Academy trustees decision to close next year, with our Council's admissions staff on hand to meet and support parents and carers.

Our Council was recently informed that Trustees of the Brackley-based school, with approval from the Department for Education (DfE), have decided to close the school at the end of the current academic year in July 2024.

This decision was made due to a significant shortfall in the take-up of places – 109 children on roll out of a possible 420 – which they said made it no longer financially viable to continue.

Following the school and DfE's closure announcement last week, our Council took



immediate steps to support families of the pupils affected and provide assurance to them that they will all have access to an alternative school within a reasonable distance from Southfield Primary.

The aim will be to ensure that friendship groups are maintained and that siblings can stay together wherever possible. A letter on place availability is being sent by the WNC admissions team, alongside details of a simplified application process, when parents will then be able to start considering alternative future options.

Members of the Schools Admissions Team are also attending sessions with parents and carers at the school from this week to discuss concerns and answer queries about the future process.

I fully understand how distressing this news will be to children and their parents. I would like to reassure them all that our Council will be doing everything possible to support them through this, by providing alternative school places still within the Brackley area, to maintain continuity and a smooth transition for youngsters for next year.

We know Southfield has faced challenges in recent years but the school has worked hard to make improvements. We have also looked at how to help the school resolve its under-capacity, such as exploring other ways to use the space for alternative educational purposes, although unfortunately these did not prove viable in the end.

Sadly the number of parents choosing to send their children there continues to be low and, at just under a quarter full, we understand why the trustees and DfE feel it is no longer financially viable to stay open from next summer.

Our priority now is to ensure all families affected by this decision are kept fully informed and updated around future steps in the process and we support Southfield staff to help them find new positions at other schools.

We are aware that some people have expressed concerns that the closure of Southfield, coupled with planned housing growth, will lead to pressures on places at nearby schools, and have provided this information to the DfE as part of our annual planning forecast.

There have also been suggestions around controlling the number of pupils admitted to Southfield but this is not something we could legally do nor would wish to, as it is important that parents are given a choice of which school their child attends, and they make this based on what best suits their family's needs and the performance of schools available to them.

Exciting opportunity to shape leisure services

Plans to procure leisure centre contracts in Northampton and Daventry have been approved by Cabinet.

There are three centres operated by Trilogy Active, including Mounts Baths, Lings Forum Leisure Centre and Danes Camp Leisure Centre, and three operated by Everyone Active, including Daventry Leisure Centre, Daventry Sports Park and Moulton Leisure Centre.

The contracts with those operators expire at the end of March 2026, so procuring a new contract(s) allows the Council the best opportunity to deliver value for money, improve service delivery and ensures we do not breach procurement law.

The contract operated by Parkwood Leisure in South



Northants expires in 2034, therefore a separate procurement exercise will take place at a later date.

At the forefront of our priorities is to improve the health and wellbeing of our residents, by appointing a contractor that will not only achieve value for money but work innovatively to enhance sports and leisure facilities in West Northants, communicate effectively with the public and add social value, such as providing sports activities that will collectively benefit the wider community.

Helping businesses achieve a sustainable future

Cllr Daniel Lister, Cabinet Member for Economic Development, Town Centre Regeneration and Growth

A new project is aiming to help local businesses with their transition to net zero.

Our Council has been collaborating with the Sustainability Local Innovation and Partnership Agenda Hub at the University of Northampton to develop the 'Towards a Net Zero West Northants (TANZ West Northants)' project, with help from funding provided by the UK Shared Prosperity Fund. This work builds on the ground-breaking Northampton Sustainability Accord.

Through this project, businesses across West Northamptonshire, including start-ups and small and medium enterprises, will be given the opportunity to participate in expert led workshops, training sessions and webinars on the transition to net zero.

This will allow them to obtain the knowledge, resources and expertise needed to create an action plan which will enable their green transition, allowing our local economy to remain competitive in an increasingly environmentally conscious world.

The project will also provide local businesses with access to the University's carbon calculator, a powerful tool enabling businesses to measure and understand their emissions, as well as support for emissions monitoring.

We are inviting businesses to be at the forefront of the sustainability revolution happening across West Northamptonshire, enabling them to contribute towards the collective effort of reaching our net zero goal by 2045.

TANZ West Northants will provide businesses with the opportunity to be a part of a supportive and collaborative community of like-minded businesses and organisations, empowering them on our journey to net zero.

Further support on offer for households

Our Council has been allocated almost £5.2million by the Department for Work and Pensions (DWP) to support residents in the fourth round of the Household Support Fund.

To make sure these funds reach and support as many West Northants residents as possible, we have implemented several strands of support with the aim of making each one available to those who need it most. We anticipate being able to support at least 33,500 households or individuals.

Working on a low wage applications

We have launched a 'working on a low wage' application, allowing adults in West Northants earning less than \pounds 400 a week to apply for a \pounds 300 payment.



To be eligible residents must be in full or part-time employment earning less than \pounds 400 a week after tax, including any government benefits, have less than \pounds 5,000 in household money, savings and investments, and must not have received the recent government cost of living payments.

Eligibility is assessed on an individual basis for each application and will consider the information and evidence provided with the application as well as other information available to us.

The £300 payment will be given in two instalments. Those that meet the criteria will receive £150 following approval of the application, with the second payment going to the same bank account 60 days later, without the need for a further application.

Tackling challenges faced by care leavers

WNC has strengthened its commitment to supporting people who have been in care, by signing up to two national initiatives aimed at reducing barriers and tackling discrimination for care leavers.

The Council signed up to the Care Leaver Covenant, to formally pledge our commitment to support those who leave care aged between 16 and 25 to live independently.

This follows on from the recent Cabinet meeting where councillors agreed to support and treat care leavers as a protected characteristic until such time it becomes legislation, joining a number of other local authorities across the country.

These are both great initiatives that I am confident are going to make a difference to outcomes for our care leavers.

We know that care leavers can often face prejudice, discrimination and challenges in accessing support, all of which I have heard first hand from our care leavers and am really passionate that we tackle.

I hope by us signing up to these as a Council, and by starting to bring about these changes internally will further support conversations with partners to encourage them to do the same.

Seasonal vaccination programme is launched

The local Covid-19 and flu vaccination programmes have been launched, ahead of the winter months.

The NHS in Northamptonshire is urging those eligible for the jabs to come forward to top up their protection as soon as possible. The vaccines can be administered together, at the same appointment, and both are vitally important to staying well this winter.

Those eligible to receive both the free COVID-19 and flu vaccines include:

- everyone aged 65 and over
- pregnant women
- adults and children (aged 6 months and over) with certain health conditions
- health and social care staff
- carers and residents of care homes for older people.

Eligible people can **book a jab on the NHS website** or app.

Our Public Health outreach vaccination programme is also underway, with homeless and rough sleepers' clinics taking place.

Council's pledge to tackle air pollution

West Northamptonshire Councillors have unanimously pledged their support to tackling air pollution with a range of actions set to move forward.

At last month's Full Council meeting, members across the political groups discussed plans to address concerns from residents about poor air quality locally.

The Council is aiming to publish a cohesive clean air strategy as early as possible next year and already working with partners to develop effective local actions.

Measures will include using nearly £300,000 of Defra grant funding to assess the health, economic and social impacts of extending the existing smoke control areas in West Northamptonshire, progressing a pilot project with local schools to promote active travel and reduce car idling and improving traffic management systems to reduce pollution levels linked to idling traffic.

At the meeting councillors also recognised West Northamptonshire Council have already made several commitments to deliver clean air, including signing up to the UK100 Net Zero Pledge in 2022, committing to be 'Clean and Green' in the corporate plan, and inheriting Northampton Borough Council's Northampton Low Emission Strategy (NLES) until 2025.

Although air quality levels in our area generally fall within Government limits, we know it is a matter of concern for our residents and that more work needs to be done improve them.

A range of actions are being planned towards improving air quality across West Northants and the unanimous support shown by councillors at last night's meeting demonstrates the widespread commitment and support to achieving this.

New measures for dog owners in place

Additional measures to encourage responsible dog ownership and ban smoking in specific public open spaces in the Northampton area have been implemented.

The Public Spaces Protection Order (PSPO) in place across the Daventry and South Northants areas has been extended across Northampton, forming a West Northamptonshire-wide order relating to dog control and prohibiting of smoking in certain public spaces.

It will remain in place for a period of two years, following approval by Cabinet last month.

The PSPO means dog owners could be fined £100 if they fail to:

- pick up their dog's mess and dispose of it properly
- carry the means to pick up after their dog
- prevent their dog from entering public places from which dogs are excluded, including children's play areas, schools and skate parks
- put their dog on a lead when asked to do so by an authorised officer.
- keep their dog on a lead in Northampton town centre, Upton Country Park Phase 2 (land between Kislingbury and Upton), near the café at Daventry Country Park, and in cemeteries, memorial gardens, allotments and sports grounds, fields and pitches when in use for authorised sporting activity.

The order restricts a person from walking more than four dogs at any one time in a public open space (unless they are a licensed dog day care provider, boarder or breeder whereby a maximum of 6 can be walked at any one time).

It is also prohibits smoking in children's play areas, land near schools, skateparks, tennis courts, multi-use games areas and bowling greens.

New courses set to support our volunteers

A series of free bite-sized courses have been launched to help up-skill front-line workers and volunteers across West Northamptonshire.

Our Council is funding the initiative, which is being run by the Northampton Hope Centre in partnership with the Community Law Service (Northampton and County).

Designed and delivered by professionals, the courses cover a range of topics including the benefits system, encouraging individuals to seek support for mental health issues, addressing debt-related challenges and other topics that empower delegates to recognise issues and understand how to refer individuals to appropriate services.

They are delivered over Zoom in easily digestible 1-2 hour sessions, and can be booked by any front-line worker or volunteer working within the West Northamptonshire area.

Streetlights are set for a major upgrade

A major project to upgrade 44,000 streetlights across Northamptonshire is set to get underway.

Balfour Beatty Living Places will **upgrade the lights** to new white LED versions over the next two-and-a-half years, in a move that will reduce CO2 emissions in the county by an estimated 1,091 tonnes of CO2 a year.

The new LED lights will also bring a range of additional benefits, including white light, which is linked to improving community safety, a reduction in light pollution and greater energy efficiency.

The lights will be replaced as part of regular maintenance rounds carried out by Balfour Beatty, making the process more efficient.

We are committed to investing to save in order to provide better value for money and an improved service for our residents.

LED lighting is far more energy efficient and therefore more sustainable. It is welcoming that the white light that LED lighting provides maintains and improves the lighting of our highways, ensuring our communities are safe. This is also a step forward in meeting our commitment becoming net zero by 2030.

Balfour Beatty took over responsibility for streetlights in Northamptonshire in 2011 under a 25-year PFI deal with the former county council. The street-lighting stock was initially replaced by standard lamps as LED was an emerging technology with relatively high unit prices and unproven life span.

International Men's Day is celebrated around the world, and in the UK focusses on the core themes of making a positive difference to the wellbeing and lives of men and boys and promoting a positive conversation about men, manhood and masculinity.

The finalists will be announced at an awards ceremony which will take place at Northampton Museum on International Men's Day on Friday 17 November 2023.

Our journey to improve children's services

Hundreds of people involved in co-producing a new strategy to improve outcomes for West Northants children with special educational needs and disabilities (SEND) gathered to mark its launch.

More than 500 parents, carers, health and education professionals attended the two events at Daventry's iCon Centre, enjoying a presentation, workshops and information sessions alongside stalls and displays from a range of local organisations providing support for SEND families.

The SEND and Alternative Provision Strategy sets out the key priorities towards ensuring the West

Northamptonshire Partnership better meets the needs of families over the next three years as the partnership continues to tackle the challenges across the system against an ever increasing demand. It was co-produced with the involvement of over 800 people who attended over 20 engagement sessions providing over 3,000 pieces of feedback.

The launch was planned and co-delivered by students from Creating Tomorrow College, which has a campus at the iCon Centre.
